'CAMMY' HAS A PREDOMINANTLY WHITE BODY WITH LARGE BROWN SPOTS ON HER BACK. SHE HAS A BROWN FACE WITH A WHITE STRIPE UP THE MIDDLE, AND BLACK SPECKLES ON HER NOSE. SHE HAS LONG LEGS AND A WHITE TAIL WITH BROWN AT ITS BASE. SHE IS FRIENDLY BUT MAY BE SKITTISH, AND WILL LIKELY AVOID ENCOUNTERS WITH PEOPLE.

SHE WAS LEFT ON THE FARM IN KNOXVILLE TO ENJOY THE SUMMER RUNNING AND PLAYING WITH OTHER DOGS.

AFTER THREE DAYS, SHE ESCAPED FROM THE FARM, AND IS BELIEVED TO BE TRYING TO FIND HER WAY HOME.

THIS LOCATION IS APPROXIMATELY 300 MILES FROM THE SITE WHERE SHE WAS LAST SEEN, IN 54 DAYS TIME MISSING. RT 90 IS ALSO THE ROUTE THAT CAMMY'S FAMILY TRAVELS WHEN GOING FROM MA TO PA.
